## <u>Terms of use</u> <u>Berglandmilch eGen (hereinafter referred to</u> <u>as "BLM") supplier portal</u>

#### 1. Terms of use coverage

BLM offers the use of this Internet-based portal (web portal) in Austria and other European countries under the following terms. The terms of use apply to all information and data retrieved, entered, transmitted or made available via the web portal.

By confirming the terms of use and subsequent use of this web portal, the terms of use for this web portal and the information and services offered therein are effective.
